The Aurora Recreation Community Center would like to offer sponsorship opportunities to assist with operating costs of our community center. Sponsorships would be good for 1 full calendar year – renewable on the date of fulfillment.

Level One – Banner Promotion: Cost \$350

Sponsor would get a banner with their logo and business information on a 4 by 8 banner in the gymnasium. This banner would get exposure in our rapidly expanding leagues, self-defense classes, and from the many users of our gymnasium for open gyms. You would also be recognized as a supporter of your local community center.

Level Two – Employee Fitness Plan: Cost \$2,700

Sponsor would be able to offer all employees and their family members a monthly membership discount of \$15 a month. A single membership at the Aurora Community Center cost \$30 a month and this would be a significant discount. Subsequent family members would also receive \$10 a person discount. This in addition to assisting the ARCC, and be a tax-deductible donation, would be a contribution to your company’s wellness policy, and would be seen favorably by employees. This sponsorship is reserved for companies with less than 100 employees. Sponsor would also receive banner in gym.

Level Three – Advertisement Agreement: Cost \$3,000
